2022 Levee Fee Collections Update.

Portnoff Law Associates Delinquent Levee Fee Quarterly Collections Update.

Motion was made to approve the proposal submitted by Mr. Rehab LLC, Three Long Lane, Mechanicsburg, PA, in the amount \$29,795.00, for the cured-in-place-pipe (CIPP) lining of an existing 18" diameter stormwater pipe from a manhole located at the Kingston levee toe to its outfall at the Susquehanna River. The distance is approximately 295 feet. Mr. Rehab is a member of COSTARS, Vendor Number 533405, and provides services under Contract Number 016-E22-220. This stormwater repair project has been previously deemed qualified by County administration as meeting eligibility requirements to be funded through ARPA.

On the question:

Mr. Hardwick: Did I read an email or two, are there two stages?

Mr. Yannuzzi: Yes, this is part two of their proposal. The first part of their proposal was when they came up and performed a camera inspection to verify existing conditions. Mr. Rehab is able to line the pipe from the levee toe to the river, but they can't line the pipe from the levee toe to the levee crest. That pipe segment has to get replaced which we are going to have to bid out.

Mr. Hardwick: So, this last amount of work is not the end of this?

Mr. Yannuzzi: Correct. The end of the overall stormwater pipe replacement effort is going to be a public solicitation for bids to replace it from the levee toe to the top.

Motion was made to request permission to issue a Request For Proposals (RFP) on the PennBid public procurement program, for design-build services to replace the existing deteriorated 18" diameter stormwater pipe from the manhole located at the Kingston levee toe, through the levee, to termination at an existing stormwater inlet on Pierce Street.

Motion was made to issue a Request For Proposals (RFP) on the PennBid public procurement program, for professional real estate appraisal services, to assist in the remaining property acquisitions for the Wyoming Valley Levee Raising Project. This RFP was originally issued back in July 2020 and no responses were received. These services will be paid out of the Wyoming Valley Levee Raising Project Fund.

Mr. Adams made the following motion: "In an effort to equitably fund the operation of the Luzerne County Flood Protection Authority (LCFPA), the Board is requesting that the LCFPA begin discussions with Luzerne County Government to restructure the relationship in such a manner that all the funding will be equally distributed to all Luzerne County taxpayers. The LCFPA believes that the current operating structure would remain in place with an advisory Board ultimately responsible to the Luzerne County Government in a manner similar to the County operations, such as the 911 Emergency Service or the Luzerne County Prison. The LCFPA Board is further directing the Executive Director and the Solicitor to begin these discussions with the Luzerne County Government within 30 days and make monthly reports on the progress of this restructuring".
