- 1. 2023 Levee Fee Collections Update.
- 2. Request motion to approve a new "Regional Stormwater Program Partnership Agreement" with the Wyoming Valley Sanitary Authority (WVSA), 1000 Wilkes-Barre Street, Hanover Township, PA 18706. WVSA is currently involved with the design of the "Abrahams Creek Stream Restoration Project" in Forty Fort. The agreement will allow the LCFPA to include its stormwater bio-retention BMP into WVSAs bid documents for the "Abrahams Creek Stream Restoration Project" to obtain cost savings vs bidding out the BMP construction separately.
- 3. Request motion to approve an agreement with Borton Lawson, 613 Baltimore Drive, Wilkes-Barre PA to provide professional design services on the LCFPAs "Command Center Stormwater Bio-retention Basin BMP" in the amount \$32,500.00. See attached proposal. This project was identified for reimbursement under our ARPA grant award.
- 4. Request motion to approve the purchase of an RC Mowers TK-60XP remote operated robotic slope mower from W.F. Welliver & Son Inc., 20 White Hall Road, Bloomsburg PA in the amount of \$57,000 with free delivery. The purchase is under the HGAC procurement program (similar to COSTARS) and was identified for reimbursement under our ARPA grant award.
