# Minutes February 20, 2024 Regular Session

### Call to Order

#### **Public Input**

Dr. Gere Reisinger gave a brief statement of the conditions behind Kirby Park and surrounding area, regarding drugs, crime, homelessness, and encampments. He asked that LCFPA work with local law enforcement to clean it up. He also advised that he believes those are to blame for the ongoing vandalism of the pedestrian barrier fencing where the levee crosses NSRR tracks in Edwardsville.

# Regular Meeting

#### On the question:

**Mr. Delaney:** As part of our minutes, I asked the Executive Director to look into one issue, that is on the last page and I would like to get a response by the end of the meeting today, if he has it.

Mr. Yannuzzi: Which item?

**Mr. Delaney:** Go down to on the question, I asked the Chairman for some direction, and I asked Chris a question about the Forty Fort levee vs. the Wilkes Barre and the \$800,000. I would just like a better explanation of that money and why it wouldn't be used to evaluate the boils off Gordon Ave.? So that is all, just a report.

Mr. Yannuzzi: Chris, were you able to look into that?

**Mr. Belleman:** Yes, I did contact them with regard to Chief Delaney's concern. The amount they have allocated for Forty Fort is about a third (\$253,658) out of their total NSF \$757,974 grant. There are other activities they are going to be involved with as part of their research effort. I will inform the Board in our March "Staff Activities/Projects Update" of that breakdown.

The Penn State researchers are scheduled to be here the week of March 3<sup>rd</sup> & 4<sup>th</sup> to start their site evaluations. The researchers are aware that the Wyoming Valley system experienced problems in Forty Fort, Wilkes-Barre, and Plymouth during the September 2011 Lee flood event. At this time they are solely focusing on Forty Fort but that effort could expand with additional grant awards.

Mr. Yannuzzi: Alright but during that meeting at Chief Delaney's request, we are going to let them know that there were issues on Gordan Ave. in 2011 and if they have any extra time, they are free to investigate that as well.

Mr. Belleman: Of course. They are aware of the other areas in our system. I will request that if there are any existing grant funds left over, or new grant funds, if they could focus on some of the issues we have experienced on the levee in Wilkes Barre.

Mr. Yannuzzi: Alright, very good.

Motion was made to approve the Luzerne County Flood Protection Authority to apply with the Pennsylvania Public Utility Commission (PUC) to formally and officially create three (3) public crossings on right-of-way currently owned by the Norfolk Southern Railway Company. The locations are as follows:

- At-grade crossing atop the levee crest in Edwardsville adjacent to Kirby Park;
- Where the levee passes beneath the railroad bridge in Kingston near the Kingston Public Works facility;
- Where the levee access ramp passes beneath the railroad bridge in Wilkes-Barre near the end of Riverside Drive.
